WITH IT'S ON THE BALLOT REPORTS, IT PROVIDED VOTERS WITH INFORMATION ON A NOVEMBER 8TH CHARTER AMENDMENT THAT REQUIRES CITY COUNCIL CONFIRMATION OF DEPARTMENT HEADS APPOINTED BY THE MAYOR. IN THE SPRING, BGR REPORTED ON SEVERAL TAX PROPOSITIONS, INCLUDING A NEW SALES TAX IN ST.
