THE BREAKFAST BRIEFING EVENTS BRING KEY POLICY ISSUES TO CITIZENS AND ALLOWS THEM TO ENGAGE WITH POLICY LEADERS AND DECISION-MAKERS. ACCESS TO EACH OF THESE EVENTS IS INCREASED BY VIDEO RECORDING THE PRESENTATIONS AND POSTING THEM ONLINE.
